TERMINATION OF AN EASEMENT

WHEREAS, on February 19, 1976, the United States of America, acting by and through the Forest Service, Department of Agriculture as Grantor, executed an easement for a road across certain land in Klamath County, Oregon, to Weyerhaeuser Company as Grantee, which deed is recorded in the public records of Klamath County, in Book M 76, at page 2999, reference to said description of said easement and the terms thereof; and

WHEREAS, for good and valuable consideration, Weyerhaeuser Company, grantee, by joining in the execution of this document, consents to the termination of said easement over and across the following lands as shown attached hereto as Exhibit A.

WHEREAS, said easement provided that the Chief, Forest Service, may terminate the easement or any segment thereof by consent of the Grantee;

NOW THEREFORE, the United States of America, by the Forest Supervisor, Winema National Forest, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, Forest Service, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement.

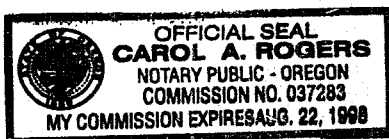
