KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated September 14, 1983, executed and delivered by TERRY THOMPSON AND JEAN DANIELS, not as tenants in common but with the right of survivorship, as grantor, William L. Sisemore, as Trustee, and KENNETH R. OSTROM AKA OSTROM AND NANCY S.
