

EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 23rd day of January, 1996, by and between JELD-WEN, inc., an Oregon corporation, herein called "Jeld-Wen" and WEYERHAEUSER COMPANY, a Washington corporation herein called "Weyerhaeuser," WITNESSETH:

WHEREAS, on the 18th day of December, 1985, Weyerhaeuser granted an easement, hereinafter called "Original Easement" to Jeld-Wen, said easement being recorded on the 10th day of January, 1986, in Volume M86 at Page 560 of the Official Records of Klamath County, Oregon. Said "Original Easement," is hereby supplemented as follows:

A. Weyerhaeuser hereby grants to Jeld-Wen, its successors and assigns, a permanent nonexclusive easement, upon, over and along a right of way, thirty (30) feet in width, over and across the following described lands in Klamath County, Oregon:
