- (1) Check + a check states, "PAY TO THE ORDER OF" and is deposited in a demand account (this may be your bank account)
- [2] Warrant/Certified Banker's Check/U.C.C. Lieu " a comptroller" or "Lien Draft" states "Pay To". This form of "Warrant", or "Check" is "HOT HEGOTIABLE" until collection has occurred. The "Warrant" is a legal instrument, and must be endorsed by both parties, then presented for collection. The "Warrant" is "not a check" and has no magnetic numbers/ routing codes. It is an assignment of a "Lieu" with a "Lieu Wumber".
- [3] Collector/Agency The collector/agency/institution may include, but is not limited to, (ie. Bank, mortgage co., credit card co., IRS, Social Security Administration, State Tax (which upon verification of the availability of funds, honored for collection)

STEF 4 - Presentation to the U.S. Treasury. The Comptroller Presents the "Comptroller Warrant/Certified Banker's Check/U.C.C. Lien Security" to the Treasury for payment.
