KNOW ALL MEN BY THESE PRESENTS, That Douglas G. Hansen

Railroad, and Easterly of a line which is 150 feet Westerly of and parallel to the East line of said West $\frac{1}{2}$ Northeast $\frac{1}{2}$ Northwest $\frac{1}{2}$ of Section 34.

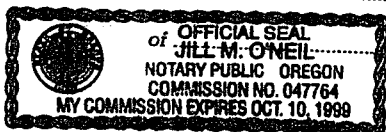
