

fault for which the foreclosure is made is grantor's failure to pay when due the following sums: Balance of
monthly installments of \$125.00 due from May 6, 1994 to present; and subsequent
installments of like amounts; subsequent amounts for assessments due under the
terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust
deed immediately due and payable, said sums being the following, to-wit: \$10,098.05 plus interest and late
