RIGHT OF WAY EASEMENT

Kerns, husband and wife, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, hereby grant(s), convey(s) and warrant(s) to THE WASHINGTON WATER POWER COMPANY, Doing Business As WP NATURAL GAS, a Washington corporation, its successors and assigns, an easement for the exclusive right to construct, reconstruct and maintain a gas regulator station and all necessary valves and appurtenances over, across, under and through the following described property in Klamath County, State of Oregon, to-wit:

A ten (10) foot by ten (10) foot parcel of land located in the Southeast Quarter (SE½) of Section Twenty-Eight (28), Township Thirty-Nine (39) South, Range Eight (8) East, W.M., Klamath County, State of Oregon being more particularly described as follows:
