Chapter 79 and other colorable acts under a de facto seal not of the People of Oregon, by the People of Oregon, nor for the People of Oregon. See the enclosed and attached "People's Seal".

Neither can I, We, waive the limitations and, or, restrictions incumbent upon you and your official Office, as duly imposed by the provisions of ARTICLE I, Section 10, Clauses 1 and 3, Organic Constitution for the united States of America.

The implied threat of issuance of the Writ(s) of Execution appearing on the face of said recorded instruments and, from your foreign venue, to have the Sheriff of Klamath County, Carl Burkhart and, or, his designee, under color of law, per your recordation and, or, filing of same, constitutes a public nuisance upon and against my, our, property and, or, rights to property, both real and personal, privately owned and possessed. Mark my, our, words:

I, We, are not debtors in possession, nor lawfully obligated to due the impossible because, the law does not require the impossible, e.g., to extinguish an alleged debt that is neither due and payable, nor, bona fide or genuine.

## CAVEAT
