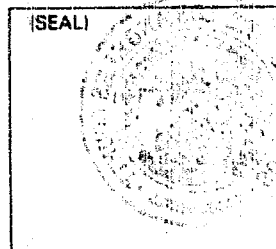

The Petition of Jerome W. Oteri, as administrator of the
Estate of JOHN OTERI, respectfully shows:

1. Petitioner is the duly appointed and currently acting
administrator of the Estate of JOHN OTERI, deceased.

2. JOHN OTERI died intestate on July 3, 1993 in the
County of Los Angeles, State of California, being at the time of
his death a resident of the County of Los Angeles, State of
California.

3. Petitioner qualified as administrator and Letters of
Administration were issued to Petitioner on September 1, 1993. At
all times since then, Petitioner has been and now is the duly

1 qualified administrator of decedent's estate. Petitioner was
2 granted limited authority by Order of this Court to administer the
3 estate without Court supervision under the Independent
4 Administration of Estates Act. This authority has not been
5 revoked.

6 4. Petitioner has performed all required duties as
7 administrator of this estate and the estate is ready for
8 distribution and is in a condition to be closed. All costs of
9 administration incurred to date including charges for legal
10 advertising and probate referee's fees have been paid except
11 closing expenses and fees.

12 5. Notice of Death has been published for the period and
13 in the manner prescribed by law, the first publication being August
14 6, 1993. Within thirty days after completion of publication of
15 this Notice of Death an Affidavit showing due publication in the
16 manner and form required by law was filed with the Clerk of this
17 Court. More than four months have elapsed since the issuance of
18 Letters, and the time for filing and presenting claims has expired.

19 6. Known creditors contacted, pursuant to Probate Code
20 §9050 to §9054 are listed in Exhibit "A", attached hereto and
21 incorporated by reference herein. All claims filed with the Court
22 and presented against the Estate have been allowed by Petitioner
23 and have been paid with the exception of the claim of Jack W. Woods
24 and Donna R. Woods and the claim of H. Allen Hooper, M.D.
25 Petitioner has taken reasonable and diligent steps to identify and
26 locate decedent's creditors and has determined that all of said
27 creditors are listed in Exhibit "A" attached hereto. The following
28 claims have been filed with the Court and presented against the

1 Estate within the statutory period and paid.

10 The claim of Jack W. and Donna R. Woods for \$5,376.77
 11 arose out of the purchase of real property by the deceased in the
 12 State of Oregon secured by a trust deed. The claim was rejected by
 13 the administrator on October 15, 1993. Thereafter, the creditors
 14 filed a lawsuit in the Superior Court of Los Angeles County,
 15 bearing case number PC 011751. The attorney for the estate
 16 negotiated a settlement of this litigation whereby the creditors
 17 received a deed in lieu of foreclosure. As consideration for
 18 settlement, the estate paid the sum of \$215.82 representing the
 19 costs of the execution of the grant deed and payment of back taxes.
 20 Attached as Exhibit "B" is a true copy of the Dismissal of said
 21 lawsuit.

22 H. Allen Hooper, M.D. filed a health insurance claim form
 23 with the Court on November 4, 1993 showing a balance owing of
 24 \$1,223.00. This form was not mailed to the administrator. The
 25 administrator had previously received a statement showing a balance
 26 due and owing of \$720. A true and correct copy of said bill is
 27 attached as Exhibit "C". This amount was verified by telephone as
 28 the true and correct amount due and owing said creditor.

1 Petitioner therefore requests authority to pay to said H. Allen
2 Hooper, M.D. the sum of \$720.00.

3 7. No notice to the Director of Health Services under
4 Probate Code §92020 is required because decedent did not receive
5 medical benefits.

6 8. An Inventory and Appraisal of the Estate was filed on
7 December 8, 1993 showing the value of the estate to be \$195,453.46.
8 The Inventory included real property owned by the deceased valued
9 at \$175,000. The administrator determined that there was
10 negligible equity in the property and there was not sufficient
11 funds available to make the monthly mortgage payments.
12 Accordingly, the administrator allowed the first trust deed holder
13 to foreclose on said property. Petitioner alleges that said
14 Inventory contains all of the assets of the estate that have come
15 to Petitioner's knowledge or into his possession with the exception
16 of the real property located in Oregon which was eventually
17 returned to Jack W. and Donna R. Woods and a trailer located in
18 the state of Oregon on said real property which was sold by the
19 administrator to one, Terry Pocock for the sum of \$700. An ExParte
20 Petition For Approval Of Sale of said trailer was executed by
21 Petitioner and approved by the Court on October 19, 1993.

22 9. No California estate tax is due because no Federal
23 Estate Tax Return has been or will be filed in which a state death
24 tax credit will apply for California property. No Federal estate
25 taxes are due. No California or Federal Income Taxes are due or
26 payable by the estate. There are no personal property taxes due or
27 payable by the estate.

28 10. The following have filed Requests for Special Notice

1 in this proceeding: Jack W. and Donna R. Woods.

2 11. Petitioner has not kept cash in his possession in
3 interest bearing accounts since all amounts appeared to be needed
4 to administer the estate and the amount of cash was less than
5 \$10,000. Petitioner is chargeable and entitled to credits
6 respectively set forth in the Summary of Account attached hereto
7 which is incorporated herein by reference. Attached is a Waiver of
8 Accounting by the daughter and sole heir of the deceased.

9 12. Attached hereto as Schedule "B" and made a part hereof
10 is a full and correct statement of all assets remaining in the
11 estate as of the close of this account.

12 13. All assets of the estate are decedent's separate
13 property. Petitioner is informed and believes and thereon alleges
14 that the following is decedent's heir under the California laws of
15 intestate succession:

19 14. The property of the estate should be distributed to
20 Jennifer Susan Oteri.

21 15. Statutory attorney's fees and administrator's
22 commissions, payable to each for their ordinary services are
23 \$904.60 and are computed in Schedule "C" which is attached hereto
24 and made part hereof.

25 16. Michael J. Peltin, attorney for Petitioner, has
26 rendered extraordinary services to the estate, which are described
27 in the Declaration in Support of Attorney's Fees, attached hereto
28 and made a part hereof. Said attorney is entitled to reasonable

1 compensation for these services and a reasonable sum is \$1,000
2 which has not been paid.

3 WHEREFORE, Petitioner requests this Court to Order that:

4 1. That the administration of this Estate be brought to
5 a close without the requirement of an Accounting.

6 2. All the acts and proceedings of Petitioner as
7 administrator be confirmed and approved.

8 3. Petitioner be authorized to pay to creditor H. Allen
9 Hooper, M.D. the sum of \$720.

10 4. Petitioner be authorized and directed to pay to
11 Michael J. Peltin, attorney at law, \$904.60 as and for statutory
12 fees for services to Petitioner and to the estate and that
13 Petitioner be allowed and credited with \$904.60 as statutory
14 commissions for services as administrator.

15 5. Petitioner's attorney, Michael J. Peltin, be allowed
16 \$1,000 for extraordinary services as specified.

17 Distribution of the estate in Petitioner's hands and any
18 other property of the decedent or the estate not now known or
19 discovered be made to the parties entitled to it, as set forth in
20 the Petition.

21 6. Such further Order be made as the Court considers
22 proper.

The facts set forth below are of my personal knowledge. This Declaration is filed in support of my request for extraordinary fees for extraordinary services which was performed by this office for this estate.

Among the assets of this estate was a trailer, not included in the estate's Inventory, located in the State of Oregon. The administrator obtained a buyer for this trailer and your declarant prepared and processed an ExParte Petition for Approval of Sale which netted \$700 to this estate.


Jack W. and Donna R. Woods filed a Creditor's Claim for \$5,376.77 for balance due on a note and trust deed pertaining to the real property owned by the decedent in the State of Oregon. This claim was rejected by the administrator and thereafter said creditor filed a lawsuit in the Superior Court of Los Angeles County. Declarant communicated with the attorney for the creditor and negotiated a settlement of the claim whereby the administrator deeded the property in Oregon back to the Creditor costing the estate \$215.82 for back taxes and recording fees. Attached hereto is an itemization of the time expended for all of said services amounting to a total of five hours. Declarant's hourly rate for services rendered is \$200 per hour. Declarant requests extraordinary fees in the sum of \$1,000.


