CONSENT TO COMMON USE

THIS AGREEMENT, entered into this 1st day of April, 1996 by and between PACIFIC GAS TRANSMISSION COMPANY, hereinafter called "Pacific", and United States of America, hereinafter called "Applicant".

WITNESSETH

WHEREAS Pacific has possession of a right-of-way for its natural gas pipelines in the County of Klamath, State of Oregon, described as follows:

A strip of land 100 feet in length and 66 feet in width and across a portion of the Southwest Quarter of the Southwest Quarter (SW 1/4 S/W1/4) of Section 7, Township 28 South Range 8 East of the Willamette Meridian.

Said right-of-way was granted to Pacific by that certain document dated September 12, 1960 and recorded September 30, 1996 in Vol. 324, at Page 295 of Deed Records of the Official Records of Klamath County, Oregon.

WHEREAS the United States of America has an interest in the real property by virtue of a right-of-way easement deed dated July 14, 1995, and recorded October 16, 1995, in Volume M95, Page 28190, in the records of Klamath County, Oregon, said portion being shown on the drawing attached hereto and hereby made a part hereof and being hereinafter called "area of common use", for the following purpose:

The use of an existing road.

Pacific hereby consents to the use of Applicant of said area of common use for the purposes hereinabove set forth, subject to the following terms and conditions:

- 1. Applicant shall obtain all necessary rights from owners of the lands crossed by Pacific's right-of-way in the event Applicant does not own said lands and rights.
- 2. Applicant shall use said area of common use in such a manner as will not interfere with Pacific's use thereof, endanger Pacific's facilities installed therein, or create an infraction of any statute, ordinance, rule, or regulation applicable to the operation and maintenance of Pacific's facilities installed in said area of common use or Applicant's use of said area of common use.

- Applicant shall use said area of common use at its sole risk and expense. 3.
- 4. Except as expressly set forth herein, this agreement shall not alter, modify, or terminate Pacific's right to use said areas of common use for all of the purposes for which said right was acquired. Applicant acknowledges the priority of Pacific's right over the right of Applicant to use said area of common use pursuant to this agreement.
- 5. Nothing herein contained shall be construed to obligate the Forest Service beyond the extent of available funds allocated or programmed for this work, or contrary to applicable laws, rules, and regulations.

This agreement shall inure to the benefit of and be binding upon the heirs, successors, and assigns of the parties hereto.

IN WITNESS WHEREOF, the parties have hereto caused this agreement to be executed in duplicate by their respective officials thereunto duly authorized.


