B. Upon any default by grantor or if all of any part of the property is add or italistened by grantor without beneficiary's consent, the beneficiary at any time, without notice, either in person or by agent, and without regard to the adequacy of any security for the indebtedness secured, enter upon and take possession of the property or any part of it, and that the entering upon and taking possession of the property shall not cure or viraive any default or invalidate any part of it, and that the entering upon and taking possession of the property shall not cure or viraive any default or invalidate any set done pursuent to such notice.

S. Lipon default by grantor in payment of uny indebtedness secured or in his performance of any agreement, the beneficiary may declare all sums secured immediately due and payable. In such event beneficiary at its election may proceed to foreclose this trust deed in equity in the manner provided by law for mortgage foreclosures or direct the trustee to foreclose this trust deed by advertisement and sale.
