A tract of land located in the SE 1/4 of Section 5, T.25S., R.8E., W.M., Klamath County, Oregon, also known as Tract 1214 - Deschutes Land Sales Unit 2, a recorded subdivision in Klamath County, more particularly described as follows:

Beginning at the Initial Point, said point being a 2 1/2" x 36" galvanized iron pipe at the Center East 1/16 corner of Section 5; thence S 00°07'49" W 2660.55 feet to a 5/8" iron pin at the East 1/16 corner of Sections 5 and 8; thence N 89°54'39" W 1333.33 feet along the line common to Sections 5 and 8 to a 1 1/4" steel pin which is the 1/4 corner common to Sections 5 and 8; thence N 00°04'32" E 2656.73 feet along the North-South Centerline of Section 5 to a 5/8" iron pin which is the Center 1/4 corner of Section 5; thence N 89°55'31" E 1335.88 feet along the East-West Centerline of Section 5 to the Initial Point.

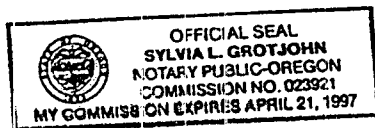
