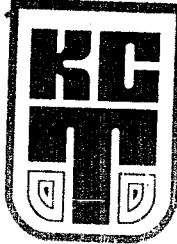

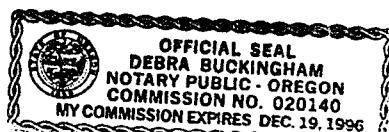


EXHIBIT "A"

DESCRIPTION

The following described real property situate in Klamath County, Oregon:
