Subject: Vacation of a portion of Crest Street

The Board of County Commissioners accepted the petition for vacation and referred it to the County Engineer by Order 96-129, dated March 20, 1996. One hundred percent of the adjoining property owners signed the petition requesting the vacation, therefore; notice to adjoining owners was not required. The Engineer provided notice to all utility companies in the area. Pacific Power is the only utility company operating in the area proposed to be vacated.

The portion of the road proposed to be vacated was never constructed and is not needed as part of the County Road System. The property has been maintained by the adjacent property owner, who would benefit from the vacation. Returning the property to the tax rolls would also benefit the public.

I recommend the vacation be granted using the legal description attached as Exhibit A. The vacation order should specify approval subject to a utility easement for Pacific Power and Light.
