NARRATIVE AND RECOMMENDATION:

The applicant wishes to establish a medical billing service as a home occupation at 2113 Summers Lane. The proposed business would have three employees and would provide a medical billing service by computer, phone, and mail. The business hours will be Monday through Friday from 8 a.m. to 5 p.m. Very little customer traffic would be anticipated. The business has been in operation for eight months at another location with only about three customers coming to the place of business. The property owner will be an employee of the business. There will be no outdoor storage of materials, and no specialized equipment will be used. This location had a previously approved home occupation in 1992 (Ashton Camera Repair). There are similar uses in the immediate area including an upholstery business,

church, beauty shop, and clothing store. Ten adjacent property owners were notified of this request, and to date (5-13-96) the Planning Department has received no response. Of the four agencies notified, one response was received from Klamath County Fire District No. 1 indicating they have no concerns with the proposal.

Staff recommends the Planning Director approve this request subject to site plan approval and compliance with Code requirements of Article 85.030.
