## 3.1 PURCHASE OPTION AGREEMENT

This Purchase Option Agreement is hereby entered into between Michael D. and Antonieta M. Rowe [Owners] and Rick and Karen Hollenbeak [Buyers]. Buyer hereby pays to Owner the sum of \$1.00 in consideration for the option set forth in this agreement. The terms of the option are as follows: The option runs from the first of August 1995 untill the lease is terminated or 2 (two) years which ever is shorter. - 5. If Buyer exercises this option, Owner will complete and sign a contract of sale within 10 business days.
- 6. This option agreement shall be binding upon and inure to the benefit of the parties, their assigns, and personal representatives.
