This deed, make this 31th day of May, 1996, between Michael R. Long, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a political subdivision of the State of Oregon, "Grantee".

WITNESSETH

WHEREAS, pursuant to a Judgment Decree and Order of the Circuit Court of the State of Oregon, in and for the County of Klamath, duly made and entered on the 11th day of February, 1993, in a suit wherein the said Klamath County, Oregon, was Plaintiff and Acuna, William & Louise Y, et al were Defendants, the hereinafter-described real properties were, by said Judgment Decree and Order, sold subject to redemption to Klamath County, Oregon; and

WHEREAS, the said real properties have been held by said Klamath County, Oregon, for a period of two (2) years from and after the date of said Judgment and Decree of Foreclosure, and no redemption has been made, and notice of expiration of redemption period has been given in the duly designated newspaper of general circulation and published in Klamath County, Oregon, to wit, the HERALD & NEWS, in two (2) weekly issues of said newspaper, not more than 30 days and not less than 10 days, prior to the date of expiration of the redemption period, proof of which notice is attached hereto as Exhibit "A", and by this reference make a part hereof; and

WHEREAS, in pursuance of the laws of the State of Oregon and for and in consideration of the Judgment Decree and Order and Sales as aforesaid, I have this day executed this deed conveying to Klamath County, a political subdivision of the State of Oregon, the following described real properties, to wit:

Said described parcels of real property were formerly owned by the said defendants indicated, bearing the tax-foreclosure list number as indicated and for the amount of judgment as indicated, all respectively, for each parcel sold by said foreclosure to the said Klamath County, Oregon, and not redeemed as provided by law;

NOW, THEREFORE, I, Michael R. Long, Grantor as aforesaid, in consideration of the premises and by virtue of the statutes of the State of Oregon, in such cases made and provided, do hereby grant, bargain, sell and convey into Klamath County, Oregon, as grantee aforesaid, and its assigns forever, the parcels of real property, hereinbefore described as fully and completely as Grantor can by virtue of the premises convey the same.

THE ABOVE-ENTITLED CAUSE came for hearing on February 11, 1993, on the complaint and application of the plaintiff for judgment and decree foreclosing tax liens, and the plaintiff appearing by and through its District Attorney, Edwin I. Caleb, and the defendants above named, except those against whom this suit has been dismissed by order heretofore made and entered herein on February 11, 1993, appearing neither personally nor by counsel, and no appearance having been made by any other person owning or claiming to own, or having or claiming to have, any interest whatsoever in any of the real properties hereinafter described; and

THE COURT finding that Klamath County, plaintiff, is a duly organized county of the State of Oregon, and a body politic and corporate under the constitution and laws of the State of Oregon; and

That the tax collector of said county did prepare a list of the real properties in said county, subject on May 16, 1992, to foreclosure for delinquent taxes, and that said list was prepared by virtue of the provision of ORS Chapter 312, and contains the names of the several persons appearing in the latest tax roll, the year or years for which taxes are delinquent on each property, together with the principal amount of delinquent taxes for each year and the amount of accrued interest to and including February 11, 1993; and

That a copy of said list marked "Exhibit A" is attached hereto and made a part of this judgment and decree; that said copy shows the names of all owners and the descriptions of all property included in the foreclosure list as prepared by said tax collector, excepting only the description of those properties and the names of the respective owners against which this proceeding has been dismissed by order of this court duly made and entered herein on February 11, 1993; and

That said foreclosure list includes real properties appearing on the tax rolls in the office of the tax collector of said county upon which taxes have been delinquent for more than three years

from the earliest date of such delinquency, together with all special assessments, fees or other charges charged against the property subject to foreclosure, which are due and unpaid for any year or years for which said delinquent taxes are due, the liens of all such delinquent taxes, special assessments, fees or other charges against each of such properties became subject to foreclosure under the provisions of ORS Chapter 312; and

That the defendants, excepting only those against whom this suit has been dismissed by said order of dismissal and each and every other person owning or claiming to own, or having or claiming to have, any interest in said properties, have neglected and refused to pay such delinquent taxes, special assessments, fees and other charges charged against such property, and interest thereon, as provided by law; and

That there is now due, owing and unpaid to plaintiff, Klamath County, the respective sums set out after the description of each of the several properties, as shown by the copy of the foreclosure list attached hereto, and in addition thereto, interest on each of the several amounts of taxes including said foreclosure list at the rate of 1 percent per month for 1980-88 and a rate of 1.333 percent per month for 1988-90 and subsequent tax years from January 15, 1993, to the date of this decree; and

That the Klamath County tax collector of said county instituted this proceeding for the foreclosure of the several liens for delinquent taxes embraced in such foreclosure list, and that a complaint and application for judgment and decree was filed in the circuit court of the State of Oregon for Klamath County, on December 29, 1992; and

That notice of the institution of said foreclosure proceedings was given in the manner provided by law, and as more fully shown by the affidavit of publication on file herein, by the mailing of notice by certified mail of said foreclosure list and its publication in the Herald and News pursuant to an order designating a newspaper duly made by the county governing board and entered of record on October 13, 1992, and that the publication of said notice was made on October 19, 1992, that the Herald and News is a newspaper of general circulation in Klamath County, and in all respects competent to publish said notice; or personal service; notice also has been provided the state attorney general for properties encumbered by a lien held by the Oregon Department of Revenue; and

That thirty (30) days have expired from the date of the publication of said foreclosure list, excepting the said defendants against whom this suit has been dismissed, no appearance has been made by any defendant or other person owning or claiming to own, or having or claiming to have, any interest whatsoever in any of the said real properties; and

NOW, THEREFORE, IT IS ORDERED and DECREED that the plaintiff have judgment and decree for the amount of taxes, special assessments, fees and other charges charged against said properties, and interest due upon and charged against each of the separate parcels

of property, as shown by the attached copy of said foreclosure list, except the parcels of land owned by the defendants against whom this suit has been dismissed, together with interest on the taxes at the rate of 1 percent per month for 1980-88 and at the rate of 1.333 percent per month for 1989-90 and subsequent tax years from the 15th day of January, 1993 to the 11th day of February, 1993, the date of this judgment and decree, and from said date last above mentioned at the legal rate of interest; and

That said judgment and decree be a several judgment against and a first lien upon each of the respective parcels of real property embraced in said attached copy of the foreclosure list for the several amounts of taxes and interest due thereon; that the plaintiff's claim for such taxes, special assessments, fees and other charges charged against such properties is paramount and superior to any and all claims to such properties by defendants, and each of them, and each and every person owning or claiming to own, or having or claiming to have, any interest, lien or claim thereon; that such lien is paramount and superior to the estate of all other persons unknown claiming any right, title, lien or interest in any of the real properties hereinbefore described; and that each and all of them hereby are forever barred and foreclosed from asserting or setting up any claim whatsoever to said real properties adverse to the lien and claim of the plaintiff, its successors or assigns, excepting the right of redemption as provided by law; and

That the clerk of the court hereby is directed to serve on the tax collector of Klamath County, Oregon, a certified copy of this judgment and decree with a list thereto attached of the properties ordered sold, with the several amounts due thereon, and the Klamath County tax collector hereby is commanded to sell each tract and parcel of real property described in said list to Klamath County, in satisfaction of the amount of taxes and interest for which such properties severally are liable; that such certified copy of this judgment and decree so delivered to the Klamath County tax collector is and shall be to all intents and purposes, a certificate of sale for each of the properties herein described, and such Klamath County tax collector shall take such further steps in the matter as are provided by law; and

IT IS FURTHER ORDERED that where any parcel of real property covered by such judgment and decree is under a registration of title certificate, such certificate shall be canceled, and that such further action shall be taken under the provisions of Chapter 478, Oregon Laws 1971, so as to properly vest title to such properties of record in the plaintiff, Klamath County.

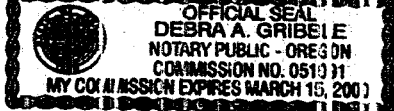

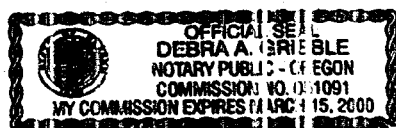
