

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated April 15, 1994, executed and delivered by Jeffrey R. 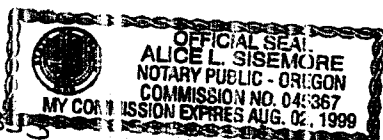
