KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 5, 1990, executed and delivered by Grant L. Knewbow & Roberta J. 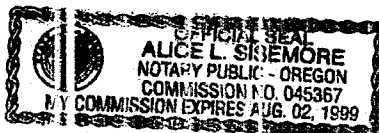
