KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated May 2, 1993, executed and delivered by Dennis C. Abel & Patricia J. 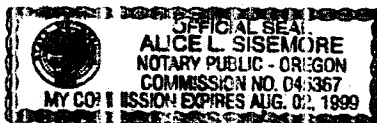
