EXHIBIT "A DESCRIPTION OF PROPERTY

A tract of land situated in the 12SE of Section 2, Township 41 South, Range 10 E.W.M., Klamath (ounty, Oregon, consisting of that portion of Lots 9, 14, 15 and 16 of MERRILL TRACTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, said portion lying South of the Burlington Railroad right of way and being more particularly described as follows:

Beginning at the Southwest Corner of said Lot 16, from which the Northeast Corner of Lot 4 of Block 1 of HODGES ADDITION to the Town of Merrill, Oregon, a subdivision recorded in Klamath County, bears \$19049'09"W, 43.33 feet; thence NO0026'10"W on the West Lines of said Lot 16 and Lot 9, 437.41 feet to a point on the South Line of said Burlington Railroad right of way; thence southeasterly on said South right of way line on the arm of a 2889.79 foot radius curve to the left, 812.49 feet (delta=16006'33") to a point on the South Line of said Lot 14; thence \$89046'46"W on the South Line of said Lots 14, 15 and 16, 679.87 feet to the point of beginning
