KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated December 28, 1993, executed and delivered by H. Floyd Hancock & Marty A. 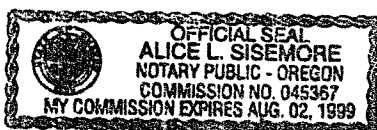
