KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated October 4, 1993, executed and delivered by Kathryn A. 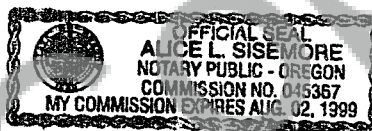
