EXTINGUISHMENT OF EASEMENTS AND

CREATION OF RASEMENT

Miller, a perpetual non-exclusive right and easement for installation and maintenance of underground utilities upon and across the following described real property, to-wit:

The Southerly 10 feet of Parcel 2 of Partition #68-92, located in Lots 1 and 2, Block 2, Tract 1080 - Washburn Park, according to the official plat thereof on file in the office of the County Clerk, Klamath County. Oregon, filed June 23, 1993.

AND, the existing easements including the terms and provisions thereof, as described in M-86 on page 7602 and in M-86 on page 7604, records of Klamath County, Oregon, are hereby extinguished.
