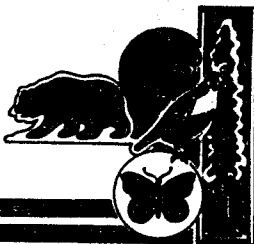

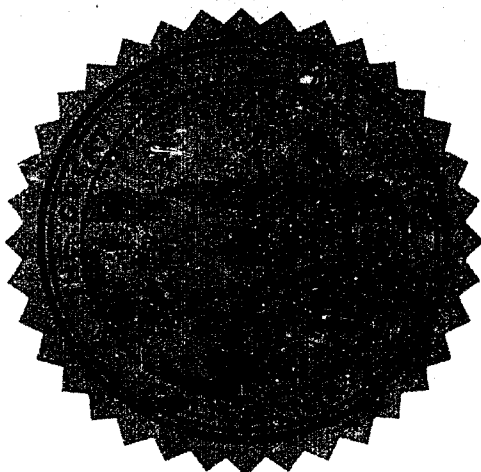

ARTICLES OF INCORPORATION
OF

SPIRIT OF TRUTH

A NONPROFIT CORPORATION

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporator hereby adopt the following Article of Incorporation:

ONE: The name of this corporation is **SPIRIT OF TRUTH**

TWO: This corporation is a religious corporation and it is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes.

The specific purpose of this corporation is to operate a church for religious purposes.

THREE: The name and address in this State of the Corporation's initial agent for service of process is

Ray Penoli, 5082 Country Club Drive, Rohnert Park, CA 94928.

This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code and Section 5130(b) of the California Corporate Code.

FOUR: The name and address of the person who is appointed to act as the initial director of this corporation is

Ray Penoli, 5082 Country Club Drive, Rohnert Park, CA 94928.

FIVE: The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows: As stated in the Bylaw of this corporation.

SIX: The period of the duration of this corporation is: perpetual.

SEVEN:

The property of this corporation is irrevocably dedicated to religious or charitable purposes.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section

501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by section 501(h) of the Internal Revenue Code], and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.
