

- 8. Loss any default by grantor or if all or any part of the property is sold or transferred by grantor without beneficiary's consent, the beneficiary may at any small without notice, atther in person of by bent, and without regard to the adequacy of any security for the indebtedness secured pents before and taker possession of the property or any part of it, and that the entering upon and taking possession of the property shall not cure or waive any default or notice of default or invalidate any act done pursuant to such notice.
