SUBORDINATION AGREEMENT

FOR ONE DOLLAR AND NO/100ths (\$1.00) and other good and valuable consideration, the SMALL BUSINESS ADMINISTRATION (SBA), an Agency of the United States of America, reference docket No EIDL 601947530-06 OR, hereby agrees that the lien of its Deed of Trust, dated February 7, 1994, and recorded November 17, 1994, Volume M94, Page No. 35380-35383, records of Klamath County, State of Oregon, given to secure the payment of \$18,300.00, with interest thereon, executed by Roberto R. Davila, as Grantor, to the SMALL BUSINESS ADMINISTRATION, as Trustee, and as Beneficiary, shall be junior and subordinate to the lien of the Transamerica Financial Services (Transamerica), not yet recorded, given to secure the payment of a Note of no more than \$118,000.00 with interest thereon, executed by Roberto R. Davila And Sylvia R. Davila, to Transamerica; provided, however, that this Subordination Agreement shall be limited to \$118,000.00, with interest thereon, and shall not extend to any further advances of Transamerica.
