KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated May 17, 1994, executed and delivered by Christopher L. Caster and Gloria J. 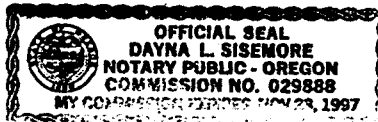
