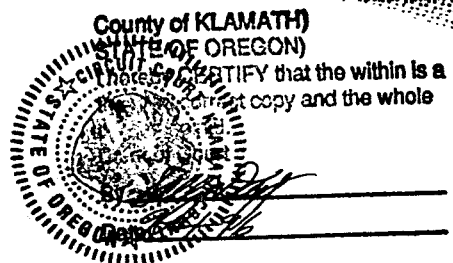
1 property is hereby forever quieted against any and all claims of Lyman F. Barber and Delores E.
