ADDENDUM TO DEED OF TRUST

Single-Family Mortgage Program Oregon Housing and Community Services Department State of Oregon

- As long as this mortgage is held by the Department, or its successors or assigns, the Lender may

 - all or part of the property is sold or otherwise transferred by Borrower to a purchaser or other transferee:
 - (I) who cannot reasonably be expected to occupy the property as a principal residence within a reasonable time after the sale or transfer, all as provided in Section 143(c) and (I)(2) of the Internal Revenue Code; or
 - (ii) who has had a present ownership interest in a principal residence during any part of the three-year period ending on the date of the sale or transfer, all as provided in Section 143(d) and (I)(2) of the Internal Revenue Code (except that the language "100 percent" shall be substituted for "95 percent or more" where the latter appears in Section 143(d)(1) (NOTE: The three-year period may be waived by the Department if the original loan was financed from 1993 A Bond Series funds); or
 - (iii) at an acquisition cost which is greater than 90 percent of the average area purchase price (greater than 110 percent for targeted area residences), all as provided in Section 143(e) and (I)(2) of the Internal Revenue Code; or
 - (iv) who has a gross family income in excess of the applicable percentage of applicable median family income as provided in Section 143(f) and (I)(2) of the Internal Revenue Code; or
 - Borrower fails to occupy the property described in the mortgage without prior written consent of the Lender or its successors or assigns described at the beginning of this Addendum; or
 - Borrower omits or misrepresents a fact that is material with respect to the provisions of
