STATE OF OREGON WELL OWNERSHIP INFORMATION FORM

Pursuant to ORS 537.788, owners of property on which a well is located shall, within 60 days following the construction of a new well or upon property transfer, record the following information in the property deed records at the appropriate County Clerks Office. Either the deed recording number or legal description of the property may be used to identify the property.

Most uses of water require a r right issued by the Water Resources Department. However, state law allows some uses of groundwater but benefit of a water right. Contact the Department for more information. The Water Resources Department of guarantee the presence of water in the desired amount on a specific property.
in	addition to the above, owners of properties on which a well is located are responsible for maintaining that well
maı	proper manner. Some basic requirements are listed below:
1.	All wells shall be maintained in a condition where they are not a threat to public health or safety, a source of contamination, or a waste of the groundwater resource.
2.	All wells shall be securely covered to prevent any foreign substance from entering the well.

- -3. Ail-wells shall be equipped with an access port or airline so that static water level information can be determined at any time.
- 4. Well casing must be protected from damage and meet minimum extension requirements.
- 5. Wells may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment must be carried out in accordance with state rules.
