KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 10, 1996, executed and delivered by Jimmy D. 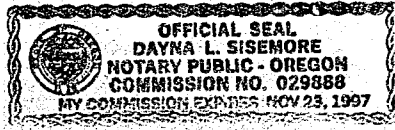
