MUELLER TRUST (TRANSFeree), all right and interest in and to that certain Recreation Residence and related improvements upon the Special Use Permit described as follows:

The following described Recreation Residence situate in Klamath County, Oregon:

All of the structures and improvements, including, without limiting the generality of the foregoing, boat dock, situated on Lot Five (5) of Block E, of LAKE-OF-THE-WOODS SUMMER HOMESITES, Winema National Forest, as shown on the Plat dated 1951, on file in the office of the Forest Supervisor, Klamath Falls, Oregon.

TOGETHER WITH: All furniture and furnishings presently in the Recreation Residence used in connection with it and the Special Use Permit for the Recreation Residence issued by the United States Department of Agriculture, Forest Service.

To have and to hold the same unto Transferee and Transferee's successors and assigns forever.

And Transferor, and Transferor's heirs and personal representatives shall warranty and defend the title hereto against all lawful claims and demands except those arising out of or related to the Special Use Permit and Klamath County, Oregon.

Transferor and Transferee acknowledge the following Warning in addition to all other provisions of this Bill of Sale:

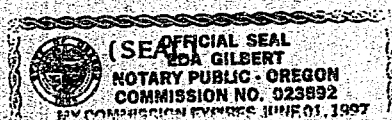
