In the Matter of Legalization of Sunset Beach Road, from Lakeport Boulevard to Midway Avenue in the Subdivision Plat of ) Terminal City, Klamath County, Oregon

ORDER 97-009

In accordance with O.R.S. 368.201 to 368.221, Sunset Beach Road, County Road No. 552-99, has been surveyed, notice of a public hearing has been served and posted, and a public hearing has been held.

There being no unresolved claims made under these proceedings:

IT IS HEREBY ORDERED that Sunset Beach Road be legalized in the location shown on Survey #5886 on file in the office of the Klamath County Surveyor. The legal description of the road is as follows:

A parcel of land, for road right-of-way purposes, situated in the SW1/4 NW1/4 of Section 18, Township 38 South, Range 9 East, Willamette Meridian, Klamath County, Oregon and being a portion of Blocks 19, 20 and 21 of Terminal City a recorded subdivision in Klamath County, Oregon; said right-of-way to be 50 feet wide, 25 feet on each side of the following described centerline:

Commencing at the Southeast corner of Block 15 of said Terminal City; thence South a distance of 29.00 feet to the true point of beginning; thence 99.84 feet along the arc of a 714.04 foot radius curve to the right (the long chord of which bears South 85° 59' 40" East - 99.76 feet); thence South 81° 59' 20" East a distance of 162.66 feet; thence 119.70 feet along the arc of a 685.57 foot radius curve to the left (the long chord of which bears South 86° 59' 26" East - 119.54 feet); thence North 88° 00' 28" East a distance of 170.14 feet; thence North 87 43' 52" East a distance of 243.55 feet.
