THIS DEED OF TRUST is between

BARRY E.LADUKE AND GWENDOLYN LA DUKE

1365 CARLSON DR. whose address is KLAMATH FALLS OR 97603 ("Grantor"); AMERITITLE corporation, the address of 222 SO.6TH ST KLAMATH FALLS, OREGON 97601 , and its successors in trust end assigns ("Trustee"); and Washington Mutual Bank , a Washington corporation, the address of which is 1201 Third Avenue, Seattle, Washington 98101 ("Beneficiary"). 1. Granting Clause. Grantor hereby grants, bargains, salls and conveys to Trustee in trust, with power of sale, the real property in KLAMATH County, Oregon, described below, and all interest in it Grantor ever gets: LOT 67, MOYINA ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE IN THE OFFICE OF THE COUNTY CLERK OF KLAMATH COUNTY, OREGON.

together with: all income, rents and profits from it; all plumbing, lighting, air conditioning and heating apparatus and equipment; and all fencing, blinds, drapes, floor coverings, built-in appliances, and other fixtures, at any time installed on or in or used in connection with such real property, all of the property described above will be considered to be either personal property or to be part of the real estate.

All of the property described above will be called the "Property." To the extent that any of the Property is personal property Grantor grants Grantor and Beneficiary, as security interest in all such property and this Deed of Trust shall constitute the Security Agreement between

This Deed of Trust shall constitute a fixture filling.

2. Security This Deed of Trust is given to secure performance of each promise of Grantor contained herein, and the payment of Eleven Thousand Eight Hundred Eighty And 00/100

Dollars (\$11,880.00) (called the "Loan") with interest as provided in the Promissory Note which evidences the Loan (the "Note"), and any renewels, modifications or extensions thereof. It also secures payment of certain fees and costs of Beneficiary as provided in Section 9 of this Deed of Trust, and repayment of money advanced by Beneficiary under Section 6 or otherwise to protect the Property or Beneficiary's interest in the Property. All of this money is called the "Debt". The final maturity date of the Loan is 09/15/16

If this box is checked, the Note provides for a variable rate of interest. Changes in the interest rate will cause the payment amount and/or Loan term to also change.

3. Representations of Grantor Grantor represents that:
(a) Grantor is the owner of the Property, which is unencumbered except by: essements, reservations, and restrictions of record not inconsistent with the intended use of the Property, and any existing mortgage or deed or trust given in good faith and for value, the existence of which has been disclosed in writing to Beneficiary; and
(b) The Property is not used primarily for agricultural or farming purposes.

4. Sale Or Transfer Of Property if the Property or any interest therein is sold or otherwise transferred by Grantor without Grantor first repaying in full the Debt and all other sums secured hereby, or if Grantor agrees to sail or transfer the property or any interest therein without first repaying in full the Debt and all other sums secured hereby, the entire Debt shall become immediately due and payable without notice from Beneficiary and bear interest at the Default Rate (as that term is defined below) from the date of the sale or transfer until paid in full. In addition, Beneficiary shall have the right to exercise any of the remedies for default permitted by this Deed of Trust.

5. Promises of Granter Granter promises:

(a) To keep the Property in good repair; and not to move, alter or demolish any of the improvements on the Property without Beneficiary's prior written consent;

(b) To allow representatives of Beneficiary to inspect the Property at any reasonable hour, and to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting the Property;

(c) To pay on time all lawful taxes and assessments on the Property;

(d) To perform on time all terms, covenants and conditions of any prior mortgage or deed of trust covering the Property or any part of it and pay all amounts due and owing thereunder in a timely manner;

(e) To keep the Property and the improvements thereon insured by a company satisfectory to Beneficiary against fire and extended coverage perils, and against such other risks as Beneficiary my reasonably require, in an amount equal to the full insurable value of the improvements, and to deliver evidence of such insurance coverage to Beneficiary. Baneficiary shall be named as the loss payed on all such (f) To see to it that this Deed of Trust remains a valid lien on the Property superior to all liens except those described in Section 3, and to keep the Property free of all encumbrances which may impair Beneficiary's security. It is agreed that if anyone asserts the priority of any the lien of this Deed of Trust for purposes of this Section 5(f).

6. Curing of Defaults if Grentor fails to comply with any of the covenants in Section 5, including compliance with all the terms of any prior mortgage or deed of trust, Beneficiary may take any action required to comply with any such covenants without waiving any other right or remedy it may have for Grentor's failure to comply. Repayment to Beneficiary of all the money spent by Beneficiary on behalf of Grantor shall be grantor on demand.

7. Detects: Sale

(a) Prompt performence under this Dead of Trust is essential. If Granter doesn't pay any installment of the Loan of time, or if there is a breach of any of the promises contained in this Dead of Trust or any other document securing the Loan, Granter will be in default and the Debt and any other money whose repayment is secured by this Dead of Trust shall immediately become due and peyable in full at the option of Beneficiary. If Granter is in default and Beneficiary exercises its right to demand repayment in full, the total amount owed by Granter on the day repayment in full is demanded, including unpaid interest, will bear interest at a rate of lifteen percent (15%) per year (the "Default Rate") from the day repayment in full is demanded until repaid in full, and, if Beneficiary so requests in writing, Trustee shall sell the Property in accordance with Oregon law, at public audition to the highest bidder. Any person except Trustee may bid at the Trustee's sale. Trustee shall apply the processes of the sale as follows: (i) to the expanses of the sale, including a reasonable trustee's fee and lawyr's fee: (ii) to the obligations secured by this Dead of Trust; and (iii) the surplus, if any, shall be distributed in accordance with Oregon law.

(b) Trustee shall deliver to the purchaser at the sale its deed, without warranty, which shall convey to the purchaser the interest in the Property which Grantor had or the interest in the Property which Grantor had or the interest which Granter absequently acquired. 8. Condemnation; Eminent Domain. In the event any portion of the Property is taken or demaged in an eminent domain proceeding, the entire amount of the award, or such portion as may be necessary to fully satisfy the Debt and all other obligations secured by this Deed of Trust, shall be paid to Beneficiary to be applied thereto.

- 9. Fees and Costs Grantor shall pay Beneficiary's and Trustee's reasonable cost of searching records, other reasonable expenses as allowed by law, and reasonable lawyers' fees: in any lawsuit or other proceeding to foreclose this Deed of Trust; in any lawsuit or proceeding which Beneficiary or Trustee is obliged to prosecute or defend to protect the lien of this Deed of Trust; and in any other action taken by Beneficiary to coliect the Debt, including any disposition of the Property under the Uniform Commercial Code, in any bankruptcy proceeding, and on any appeal from any of the above.
- 10. Reconveyance Trustee shall reconvey all or any part of the Property covered by this Deed of Trust to the person entitled thereto, on written request of Grantor and Beneficiary, or upon satisfaction of the Debt and other obligations secured and written request for reconveyance by Beneficiary or the person entitled thereto.
- 11. Trustee; Successor Trustee in the event of the death, incapacity, disability or resignation of Trustee, Beneficiary shall appoint in writing a successor Trustee, and upon the recording of such appointment in the mortgage records of the county in which this Deed of Trust is recorded, the successor trustee shall be vested with all powers of the original Trustee. Trustee is not obligated to notify any party hereto of a pending sale under any other deed of trust or of any action or proceeding in which Grantor, Trustee or Beneficiary shall be a party unless such action or proceeding is brought by the Trustee.
- 12. Miscellaneous This Deed of Trust shell benefit and obligate the parties, their heirs, devisees, legatees, administrators, executors, successors and assigns. The term Beneficiary shall mean the holder and owner of the note secured by this Deed of Trust, whether or not that person is named as Beneficiary herein. The words used in this Deed of Trust referring to one person shall be read to refer to more than one person if two or more have signed this Deed of Trust or become responsible for doing the things this Deed of Trust requires. If any provision of this Deed of Trust is determined to be invalid under law, that fact shall not invalidate any other provision of this Deed of Trust, but the Deed of Trust shall be construed as if not containing the particular provision or provisions held to be invalid, and all remaining rights and obligations of the parties shall be construed and enforced as though the invalid provision did not exist.
