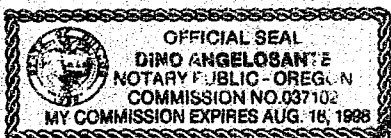

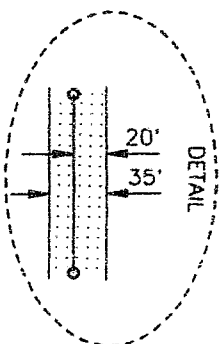

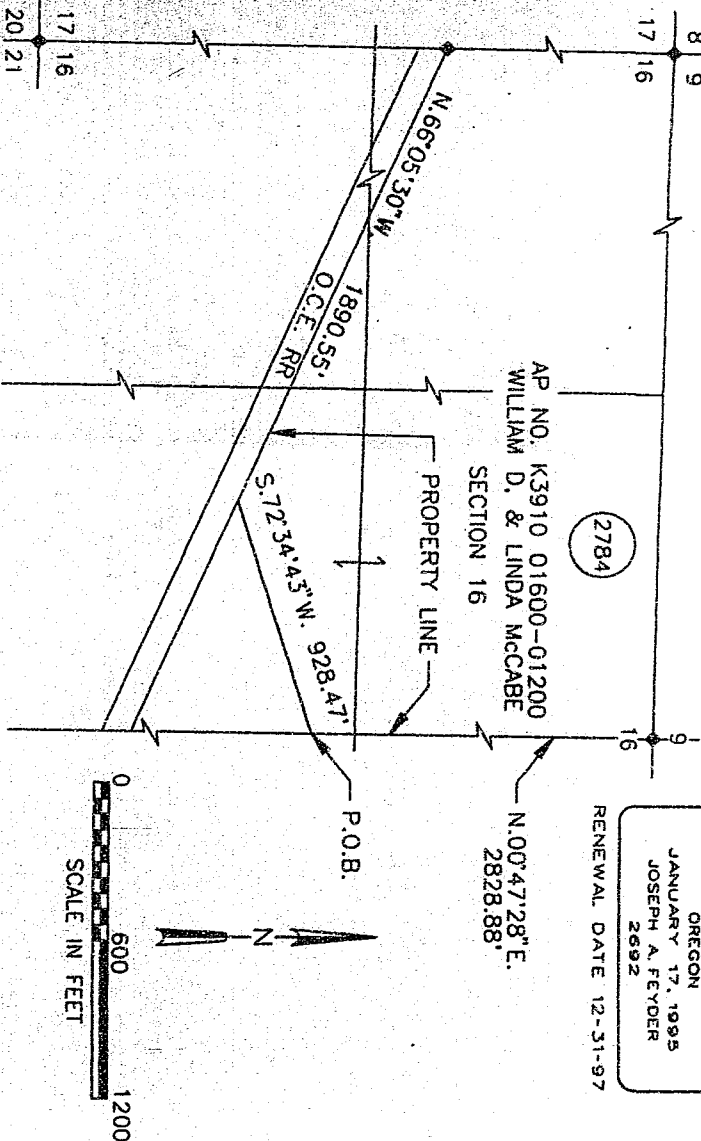

On 11/11/73, the following information was received from the Bureau of the FBI, New York City, regarding the above captioned case:

THE COURT OF COMMONS HAS REPORTED THAT THE HOUSE OF LORDS HAVE ORDERED THAT THE HOUSE OF COMMONS SHOULD BE KEPT OPEN FOR THE PURPOSE OF RECEIVING PETITIONS AND ANSWERING QUESTIONS.
