MEMORANDUM OF LAND SALE AGREEMENT

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$18,300.00, all deferred payments bear interest at the rate of 9% per annum from the date of said Land Sale Agreement until paid.

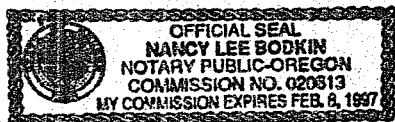
