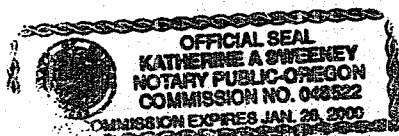
THIS IS TO CERTIFY That I am the Attorney for the
