

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 21, 1993, executed and delivered by CURTIS R. JUDD and NANCY M. 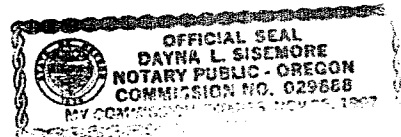
