This length of time may be extended to a period not exceeding 12 months if the delegation of power is made to a school administrator. Such a delegation may consist of a period not exceeding the period not exceeding the term of active duty service plus 30 days when the parent or guardian is a member of the organized militia of the State of Oregon or any other reserve component of the United States Armed Forces who is required to eather and serve in the active military service of the United States under a call or order by the President of the United States. In this case, if the minor child is living with the child's other parent, the delegation must be made to the parent with whom the child is living unless the court finds that such a delegation would not be in the child's best interests.
