Under the provisions of ORS Chapter 701, the Construction Contractors Board finds that the respondent owes the claimant \$5,400.00, payable in installments of no less than \$750 by May 1, 1996; no less than an additional \$500 payable by June 1, 1996; no less than an additional \$500 payable by July 1, 1996; with the entire remaining unpaid balance payable by August 1, 1996, based on consideration of the stipulations of the parties made during the course of an Administrative Hearing held December 19, 1995, a copy of which is attached.
