EXCHANGE DEED

THIS DEED, made this $28^{\frac{1}{10}}$ day of February, 1996, between the UNITED STATES OF AMERICA, Grantor, acting herein by and through the Forest Service, United States Department of Agriculture, and STATE OF OREGON, acting by and through its State Land Board, Grantee.

WITNESSETH: That the Grantor, hereunto authorized by the Act of Congress approved March 1, 1911, (36 Stat. 961, as amended; 16 U.S.C. 516), the provisions of which have been complied with, and also in accordance with the terms of the Exchange Agreement dated November 27, 1995, for and in consideration of the conveyance of State of Oregon lands in the County of Hood River, State of Oregon, TO HOOD RIVER COUNTY, a political subdivision of the State of Oregon, as stated in the deed to Hood River County; and, in addition thereto, pay to State of Oregon, the sum of TEN THOUSAND DOLLARS (\$10,000), the receipt of which is hereby acknowledged, does hereby remise, release, and quitclaim unto the Grantee all its rights, title, and interest in and to the real property situated in County of Klamath, State of Oregon, within the boundaries of the Winema National Forest, described as follows:

T. 33 S., R. 7 1/2 E., W.M. sec. 13, lots 5, 6, and 7; sec. 24, N1/2.

Acres 143.66 320.00

Containing 463.66 acres, more or less.

EXCEPTING AND RESERVING TO THE UNITED STATES OF AMERICA, from the land so granted, a non-exclusive perpetual easement, for existing roads as shown approximately on attached Exhibit A, consisting of 1 sheet, and more particularly identified and described herein.

Such easement shall be 20 feet on each side of the centerline, the location of said roads being more particularly described as follows:

A. Forest Development Road No. 6214000 (Segment 1)

Beginning at a point on the North line of lot 5 of sec. 13, T. 33 S., R. 7 1/2 E., W.M., which point is approximately 200 feet east of the south 1/16 corner of the West section line, of said sec. 13; Thence in a southerly direction, approximately 1900 feet, over and across lot 5 of sec. 13, to a point on the south section line of lot 5 of sec. 13, which point is approximately 620 feet east of the section corner common to secs. 13, 14, 23 & 24, T. 33 S., R. 7 1/2 E., W.M.

B. Forest Develoument Road No. 6214000 (Segment 2)

Regiming at its intersection with Segment 1 of Forest Development Road No. 6214000 at a point on the south section line of lot 5 of sec. 13, T. 33 S., R. 7 1/2 E., W.M., which point is approximately 620 feet east of the section corner common to secs. 13, 14, 23 & 24, T. 33 S., R. 7 1/2 E., W.M.; Thence in a southwesterly then southeasterly direction, approximately 4750 feet, over and across the W1/2NW1/4 and the SE1/4NW1/4 sec. 24, T. 33 S., R. 7 1/2 E., W.M., to a point on the south line of the SE1/4NW1/4 of said sec. 24, which point is approximately 250 feet west of the center quarter corner of sec. 24, T. 33 S., R. 7 1/2 E., W.M.

C. Forest Development Road No. 6214310

Beginning at a point on the North section line of the NE1/4NE1/4 of sec. 24, T. 33 S., R. 7 1/2 E., W.M.; which point is approximately 900 feet west of the section corner common to secs. 13 & 24, T. 33 S., R. 7 1/2 E., W.M. and secs. 18 & 19, T. 33 S., R. 7 E., W.M.; Thence in a southeasterly direction, over and across the NE1/4NE1/4 of said sec. 24; Thence in a southerly direction along the East section line of the SE1/4NE1/4 of sec. 24, approximately 2900 feet, to a point on the East section line of SE1/4NE1/4 of sec. 24, which point is the center 1/4 corner of said East section line of sec. 24, T. 33 S. R 7 1/2 E., W.M.

D. Forest Development Road No. 6214380

Beginning at its junction with Forest Road No. 6214000 in SE1/4NW1/4 of sec. 24, T. 33 S., R. 7 1/2 E., W.M.; Thence in a southwesterly direction, approximately 1200 feet, over and across S1/2NW1/4 of sec. 24, to a point on the south line of the S1/2NW1/4 of said sec. 24, which point is approximately 400 feet east of the center 1/4 corner of the West section line of sec. 24, T. 33 S., R. 7 1/2 E., W.M.

E. Forest Development Road No. 6214381

Beginning at its junction with Forest Road No. 6214380 in the SW1/4NW1/4 of sec. 24, T. 33 S., R. 7 1/2 E., W.M.; Thence in a southerly direction, over and across the SW1/4NW1/4 of sec. 24, approximately 150 feet, to a point on the south line of the SW1/4NW1/4 of said sec. 23, which point is approximately 1150 feet east of the center 1/4 corner of the West section line of sec. 24, T. 33 S., R. 7 1/2 E., W.M.

F. Forest Development Road No. 6214400 (Segment 1)

Beginning at its junction with Forest Road No. 6214000 in SW1/4NW1/4 of sec. 24, T. 33 S., R. 7 1/2 E., W.M.; Thence in a southwesterly direction, approximately 420 feet, over and across SW1/4NW1/4 of said sec. 24, to a point on the West section line of SW1/4NW1/4 sec. 24, which point is approximately 650 feet north of the center 1/4 corner of the West section line of sec. 24, T. 33 S., R 7 1/2 E., W.M.

G. Forest Development Road No. 6214400 (Segment 2)

Beginning at its junction with Forest Road No. 6214000 in NW1/4NW1/4 of sec. 24, T. 33 S., R. 7 1/2 E., W.M.; Thence in a northwesterly direction, approximately 200 feet, over and across NW1/4NW1/4 of said sec. 24, to a point on the West section line of NW1/4NW1/4 sec. 24, which point is approximately 200 feet north of the north 1/16 corner of the West section line of sec. 24, T. 33 S., R 7 1/2 E., W.M.

IT IS AGREED that the United States of America, reserves for itself, its permittees, contractors, and assignees, the right to use the roads without cost for all purposes deemed necessary or desirable by the Forest Service in connection with the protection and administration of National Forest System Lands or resources accessed by the above described roads, now or hereafter owned or controlled, provided that use for commercial hauling purposes, other that the removal of timber cut in construction or maintenance of the road or other occasional incidental use, shall be made only after arrangements have been made to pay or perform its pro-rata share of road maintenance.

PROVIDED, That if the Regional Forester determines that the roads, or any segment thereof, are no longer needed for the purposes reserved, the easement shall terminate. The termination shall be evidenced by a statement in recordable form furnished by the Regional Forester to STATE OF OREGON, or its successors or assigns.

SUBJECT TO treaty rights between the United States of America and the Klamath Indians, more specifically defined as hunting, fishing, trapping, and foodgathering rights (Civil Action No. 77-2628, U.S. Court of Appeals, Ninth Circuit).

TO HAVE AND TO HOLD the above-described real property unto the Grantee or the Grantee's assigns forever, together with all hereditaments and appurtenances thereunto belonging.

This instrument will not allow use of the property described in the instrument in violation of applicable land use laws and regulations. Before signing or accepting this instrument, the person acquiring fee title to the property should check with the appropriate city or County Planning Department to verify approved uses.
