MTC 37304KR IRRIGATION PUMP AND WATER RIGHTS AGREEMENT

This agreement is made this <u>Hth</u> day of <u>October</u> 1996, by Jim and Patricia Huckabay, owner of certain real property in Klamath County, Oregon, 1996, by Jim and more specifically described below, and is made to allocate the existing irrigation water supply for said property between Major Land Partition LP-32-91, Parcel 1 and the following described property situated in Township 34 South, Range 8 East of the Williamette Meridian, Klamath County Oregon.

WITNESSETH:

EXHIBIT "A" LEGAL DESCRIPTION

The following described property is situate in Township 34 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

Section 27: SW1/4 lying Southerly of the Sprague River Road.

Section 28: E1/2 SE1/4 lying Southerly of the Sprague River Road and all that portion of the E1/2 SW1/4 NE1/4 and the SE1/4 NE1/4 lying South of the Chiloquin-Sprague River at the intersection of the Westerly right of way line of the Chiloquin-Sprague River center section line 1664.0 feet to the Southwest corner of the E1/2 SW1/4 NE1/4 of aforesaid Section 28; thence North 2 degrees 26' East along the West boundary of the aforesaid Section 28, 912.0 feet, more or less, to the Southerly Southeasterly along said right of way boundary as follows: South 66 degrees 50' East 670 53 degrees 06' East 299.5 feet, and South 48 degrees 03' East 215.8 feet, more or less, to the point of beginning.

Section 34: W1/2 NE1/4, NW1/4 lying Southerly of the Sprague River Road.

- Jim and Patricia Huckabay are the owners of the above referred and 1. 2.
- Located in the E1/2 SE1/4 Sec 28 is an irrigation well with a 50 horse pump, together with a distribution system for water right permit # G3796. 3.
- The Sprague river Hwy divides the Huckabay Land into two parcels.

4. The irrigation well and pump described supply irrigation water to land on each side of the highway. Upon the sale of one parcel, each of the two parcels will share in the supply of water from the pump to the extent allowed under the water right. 5. The owners of the property described as Major Land Partition 32-91, Parcel 1 agree to reimburse the property owners, of the parcel the well is located on, for the prorated share of electrical, expenses, maintenance, repair and replacement of the well pump and distribution system. The prorated expenses are to be paid November 1 of each year. Costs are to be prorated on an irrigated acre basis as given on the water rights. The rights and obligations provided herein shall run with the land as 6. to all property burdened and benefitted by such rights and obligations. The rights, covenants and obligations contained in this agreement shall bind, burden and benefit each party's successors' and assigns, lessee's and mortgages.
