## WARRANTY DEED

Range 6 East, Willamette Meridian

Grantor hereby warrants and represents to grantee that upon delivery of this Deed to grantee,  
fee title to the real property described herein shall be vested in grantee, subject only to  
current real property taxes and assessments, a lien not yet delinquent, to those exceptions to  
title described in grantor's policy of title insurance, and any public road or highway  
easement, public utility easements and waste disposal requirements recorded October 3,  
1962, Declaration of Restrictions recorded October 26, 1967, in Vol. M67 Page 8359, and  
Amended Declaration of Restrictions recorded August 13, 1970, in Vol. M70 Page 7024;  
provided, however, that grantor's liability with regard to the warranty and representation

given under this provision shall be limited to the amount of proceeds actually received by grantor under the above-described title policy.

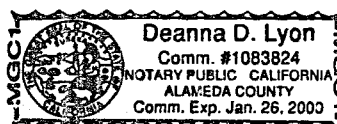
