This matter came before Michael L. Brant, Hearings Officer for Klamath County, Oregon, on October 4, 1996, in the Klamath County Museum Meeting Room, Klamath Falls, Oregon. The hearing was held pursuant to notice given in conformity with the Klamath County Land Development Code and related statutes and ordinances. The Klamath County Planning Department was represented by Mr. Kim Lundahl and the recording secretary was Ms. Karen Burg. The Klamath County Planning Department staff report was received.

FINDINGS OF FACT

Respondent constitucted a residence on 12.32 acres north of the Crescent Lake Cutofil, west of Jug Drive, Crescent, without obtaining Planning Department, Building Department and Health Services Department permits and approvals. Respondent has agreed to the conditions which are set forth in the following ORDER.

CONCLUSION OF LAW

Respondent is in violation.

ORDER

Respondent shall apply for:

1. A septic system evaluation by November 1, 1996.

2. Purchase a septic installation permit and submit retro-permit building plans by December 1, 1996.

3. Remit payment to the Building Official for the retro-permit by



December 15, 1996.

4. Appear before the Hearings Officer January 3, 1997 to confirm compliance with this Order.
