KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deeds dated February 1, 1985 and September 6, 1988, executed and delivered by ROGER L. 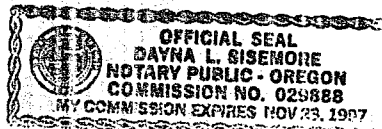
