The value of this gift is acknowledged to be \$20,000.00

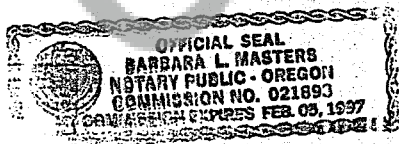
