

DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deeds dated June 28, 1994 / August 14, 1995, executed and delivered by JOHN W. APPOLONIO and DONINIC A. APPOLONIO and IRAGARD C.
