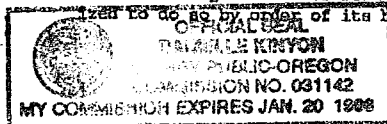
To Have and to hold the same unto the said grantees and grantees's heirs, successors and assigns forever.

LEGAL DESCRIPTION

Beginning at a 5/8 inch iron pin marking the Northwest corner of the SW1/4 SE1/4 of said Section 25; thence North 00 degrees 07' 03" East, 689.06 feet; thence EAST, 510.11 feet to a point on the Westerly boundary of "River West", a duly platted and recorded subdivision; thence South along said boundary, 257.73 feet; thence South 62 degrees 49' 00" West along said boundary, 157.44 feet to a 5/8 inch iron pin marking the Northwest corner Lot 1 Block 5 of said subdivision; thence South 27 degrees 11' 00" East along said boundary 150.00 feet to a 5/8 inch iron pin marking the Southwest corner of said Lot 1; thence leaving said subdivision boundary but continuing South 27 degrees 11' 00" East, 70.00 feet; thence South 62 degrees 49' 00" West, 530.76 feet to a point on the West line said SW1/4 SE1/4 Section 25; thence North 00 degrees 07' 03" East, 78.78 feet to the point of beginning.
