رس کار The STATE OF OREGON, acting by and through the STATE BOARD OF HIGHER EDUCATION on behalf of OREGON INSTITUTE OF TECHNOLOGY, hereinafter referred to as GRANTOR, does hereby grant unto U S WEST COMMUNICATIONS, Inc., a Colorado corporation, and to its licensees, successors and assigns, hereinafter referred to as GRANTEE, an Easement of Right-of-Way for the construction, reconstruction, operation, maintenance, repair, alteration, inspection, replacement and removal of such telecommunications facilities as GRANTEE may require upon, over, across, under and through the following described property in Klamath County, State of Oregon, to wit:

That certain tract of land located in Tax Lot 38 09-4900, Section 20, Township 38 South, Range 9 East of the Willamette Meridian in Klamath County, Oregon;

The South 25 feet lying West and South of "West Campus Drive" of that portion of the real property conveyed to the State of Oregon, acting by and through the State Board of Higher Education and as shown on the deed recorded in Volume 324 at Page 372 of Klamath County Deed Records, described as beginning at the iron pin marking the Southeast corner of the NW 1/4 of the NE 1/4 of said Section 20; thence South 89°21' East 393.24 feet; thence North 0°46' East 1962.00 feet; thence North 89°05 West 2675.11 feet; thence South 0°50' West 1969.63 feet; thence South 89°10' East 966.14 feet; thence South 89°21' East 1318.1 feet to the point of beginning.

Also, the North 25 feet of the South 37 feet of that portion of said real property above described in deed Volume 324 at Page 372 lying East and South of "Campus Drive."

GRANTEE shall have all rights of ingress and egress necessary, useful or convenient, for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including but not limited to, the right to remove obstructions which may injure or interfere with the GRANTEES use, occupation, or enjoyment of this easement and the operation, maintenance and repair of GRANTEES telecommunications facilities.

GRANTEE shall, upon every occasion that such telecommunications facilities are constructed, maintained, replaced, reconstructed, or removed, provide GRANTOR reasonable notice and restore the premises of the GRANTOR, and any buildings or improvements disturbed by GRANTEE, as near as practicable.

GRANTEE agrees to indemnify and hold harmless GRANTOR and the members, officers, employees and agents of the Oregon State Board of Higher Education against any and all damages, claims, demands, actions, causes of action, costs and expenses of any kind or nature arising from the activities of GRANTEE, its agents or employees in connection with the use of this easement.

GRANTOR shall have the right to the use and enjoyment of said property subject to the above-described easement but such use shall not conflict or interfere with GRANTEE'S surface or subsurface rights hereunder or disturb its lines or appurtenances and no road or other structure or excavation shall be constructed or maintained on, over, or along said right-of-way without the prior written consent of GRANTEE. Such consent shall not be unreasonably withheld.


